The Head of Ultrasound Services have responsibility for the organisational overview and operational delivery to ultrasound.

The department is supported by Lead sonographer who's responsibility are:

- Review updates and operationalising all ultrasound arrangements, systems, processes, policies, and SOPs, alongside all stakeholders
- Work with Education department to ensure ultrasound training is delivered to all colleagues
 within their designated region, including ensuring practitioners and operators are competent
 and conform to the training. When necessary undertake training and re-training of staff and
 student 'operators' as required.
- Work with the relevant colleagues to produce tenders

The centres are also supported by Ultrasound Mentors who's responsibilities are:

- Provide support to MSUK staff who are on a recognised ultrasound training programme
- Provide support to all operators/practitioners
- When not working as a mentor, to provide services to the clinic as required and within their scope of practice
- Assist the sonographers in gathering data for audit purposes
- Management of client studies as per the ultrasound SOP



The role

You will be working as part of a friendly, welcoming team supported by our experienced Lead sonographer to deliver clinically safe and high-quality treatment to patients who are presenting for termination of pregnancy.

To be an effective member of the ultrasound team, you must be focused on providing the highest standard of safe and effective patient care. The post holder will contribute to the provision of the highest standards of sonography practice and patient care, always producing a high standard of professional ultrasonography practice, maintaining a level of professional accountability in accordance with the SOR / COR statements of professional conduct, whilst undertaking all ultrasonography duties performed within the scope of practice of the appointed role.

Key Responsibilities

- Completing the examination of all patients who require a dating scan to ensure the client is within legal limit for abortion and that the correct treatment is offered.
- Communicate scan findings with colleagues in order to offer appropriate treatment
- Perform scans for clients who attend for post-treatment follow-up and identify retained products of conception and/or other pathology.
- Produce written reports in line with local SOP.
- Support colleagues to complete the practical requirements of their ultrasound course
- Deal sensitively with clients before, during and after their scan
- Produce images in accordance with local SOP and interpret observations
- Keep accurate and up-to-date patient care records
- Regularly check ultrasound equipment
