### The department/team

It also is responsible for designing and delivering strategic operational and formative research studies. The team strives towards:

- **Impact** ensuring evidence and insights drive scale, quality and sustainability of MSI programming across all service delivery channels.
- High quality research studies are ethical, methodologically robust, strategic, and evidence is
  disseminated effectively to improve programme outcomes.
- **Collaborative** studies conducted in partnership with country programmes and other external research groups to ensure analytical and research capacity building and maximum research utilisation.

### The role

The advisor will work primarily on the Women's Integrated Sexual Health (WISH) program, a high-value multicountry programme which aims to improve access to Sexual and Reproductive Health and Rights (SRHR) for women and girls in areas of highest unmet need. WISH is split into two separate Lots – Lot 1

works across 11 countries in West and central Africa (Nigeria, Sierra Leone, Democratic Republic of Congo, Senegal, Mali, Niger, Burkina Faso, Mauritania, Chad, Cameroon, Cote d'Ivoire) and is implemented by a consortium led by MSI. MSI is also a consortium partner in WISH Lot 2, which is led by IPPF, with inputs from 8 MSI country programmes. WISH combines delivery of SRH services with work to strengthen national ownership of WISH outcomes through supporting an enabling policy environment, strengthening domestic resources for family planning and building the capacity of the public sector.

In addition to the technical responsibilities listed below, the Evidence and Impact Advisor is expected to be the MSI technical and thematic expert, representing MSI E&I team within WISH consortium. The Evidence Advisor is charged with providing technical leadership and oversight of key consortium deliverables; drawing data together; identifying strategies and actions that need to be taken because of the data; developing dissemination strategies and action plans; etc. This post will also be a key source of strategic support to the MSI FCDO programme management team, supporting reporting needs and more in-depth analytics, and enabling consortium partners in-country to identify 'what works' and also enable rapid course correction.

## **Key Responsibilities**

- Lead as Technical Expert, On Data Collection, Quality Assurance, Analysis And Reporting Across The WISH & Wish2Action Programmes
  - Lead on data management and analysis for quarterly and annual reporting
  - Be the technical liaison and manage WISH Third Party Monitoring verification (/audit) workstream
  - Represent MSI at the TPM working groups and provide technical steer on key thematic areas
  - Provide capacity building and quality control to our consortium partners as needed
  - Analyse WISH specific data to generate insights that could lead to programme improvement and share them effectively within the consortium, wider MSI and external audience
  - Develop, maintain and update WISH performance dashboard to facilitate reporting and performance monitoring
- Serve as the WISH Learning Lead Advising on The Evidence and Learning Agenda Across The Consortium
  - Manage and disseminate WISH Global Goods tailored to different audiences
  - Develop evidence and tools as WISH Global Goods deliverables and ensure they are properly disseminated across the consortium, MSI and external audience as appropriate
  - Manage relationship with the Third Party Monitor and provide technical stewardship on their Evidence & Learning workstream and deliverables (input, provide technical steer and review all deliverables in concept, protocol and write-up)
- Serve as The Technical Lead On Specific Leave No One Behind Thematic Areas
  - Be the technical lead for poverty and inclusivity measurement strategies. Support with generating country level national benchmarks for poverty and disability. Analyse routine data and CEI to generate insights on what strategies work in improving access to last mile clients.

programmes.

- Be the technical lead in the use of geospatial mapping for Pillar 1 workstreams by ensuring that all country programmes have access to geospatial poverty and demographic maps; teams are trained on how to make effective use of them; and document the evidence on the impact of using such data
- Ensure MSI evidence is effectively disseminated by producing digestible and impactful evidence products, including digital content (knowledge hubs, newsletters, SharePoint), printed content (evidence briefs, reports) and oral content (presentations at technical meetings, symposia, conferences).
- Provide Technical Support To MSI Country Programmes To Ensure Quality Evidence Generation, Agile Data Use And Adaptive Programming Across All Aspects Of Operations And Service Delivery
  - Serve as a point of contact and advisor for RME teams in 2/3 country programmes
  - Review and help finalise annual and project-specific Monitoring and Evaluation (M&E) plans, aligning to global indicators where possible.
  - Co-develop, review, and provide ongoing support to priority research and learning projects in countries to ensure generation of actionable insights for operations.
  - Work with country programmes to develop budgeted evidence and research plans to support strategic decision-making and robust evaluation of key donor-funded projects.
  - Support the Programme Design and Development team on country-specific new project proposals, to ensure that performance measurement indicators align with MSI global standards, and that all evidence-generating activities are adequately planned and budgeted for

#### Roll out data utilisation and research tools to support performance management:

- Mentor and coach country programme evidence teams to harness the power of MSI data systems to guide strategic decision-making by co-developing, evolving and/or supporting embedding of global tools, including performance dashboards, market research protocols, annual client exit interviews, impact models, quality assessment and client feedback tools.
- Support country teams to collect and use relevant market data from secondary sources such as national surveys or published reports.
