The role

To ensure the smooth running of the UK Vasectomy sites by: overseeing the Nursing and Vasectomy Care Assistant team; being part of the supervisory team; being the main contact for team issues and concerns; supporting team recruitment, training and supervision; and supporting the Vasectomy management team as required.

Key Responsibilities

- Although the role will be supernumerary, you will be required to provide hands-on client care in the provision of services to clients when needed
- Lead on changes in clinical practice, acting as a positive and enthusiastic role model
- Monitor and enforce standards of client and clinical care, correcting or improving performance where appropriate
- Identify team needs, both permanent and sessional team members, ensuring that learning and competency needs are defined and met, including requirements for the role
- Work with the Clinical Services Matron and Head of Vasectomy to ensure the Vasectomy team is supported and well managed remotely

- Take an active role in recruitment by anticipating clinic requirements, submitting requisitions and job advertisements, interviewing candidates and completing the recruitment, onboarding and induction process
 - Support the Clinical Services Matron in the clinical management of the Vasectomy team, carrying
 out additional tasks as required- such as auditing, attending meetings and deputising for the CSM
 in their absence.

Team Supervision and Development

- Brief team on a regular basis (medical and nursing) and ensure understanding of all local and corporate guidelines
- Develop and implement good nursing practices
- Organise and run development activities for administrative, nursing and medical team members
- Recruitment, selection and induction of new team members
- Motivate, train and coach team members and provide feedback on performance to individuals
- Carry out team member appraisals and follow up on outcomes
- Monitor team member performance on an on-going basis and, in conjunction with the Clinical Services Matron, take corrective action as appropriate
- Implement policy and procedural changes as required, in line with local and corporate guidelines, acting as a positive role model and ambassador for change

Administration

- Input and retrieve computerised client and team information
- Receive, monitor and check professional registration, DBS, indemnity and hepatitis B records for the Nursing teams
- Contribute towards managerial documentation and audits as required

Quality Management, Health & Safety and Infection Control

- Ensure that National Minimum Care Standards are met; liaise with Care Quality Commission officials as required
- Contribute towards initial client complaints and answer queries



- Undertake quality audits across the Vasectomy sites
- Establish and maintain MSI Quality Management System, BS EN ISO 9002 and implement policy and procedural changes in line with the system
- Contribute to Health and Safety in the centre in accordance with MSI processes and procedures
- Adopt the role of IPC Lead for MSIUK Vasectomy liaising with MSIUK Infection Prevention and Control Specialist.
- Be responsible for Infection Control in the centre, liaising with external Occupational Health Service as necessary

Safeguarding Leadership

- Responsible for ensuring good safeguarding practice is maintained in line with MSI safeguarding policies
- Adopt the role of Safeguarding link for MSIUK Vasectomy liaising with named Nurse/Midwife for Safeguarding
- Address issues with safeguarding practice on an individual or centre level, and reporting risks to subject matter experts/ executive team
- Providing safeguarding supervision to clinical colleagues
- Ensuring safeguarding competencies are completed for clinical colleagues
- Be a resource of knowledge and information to all staff within their site/area
- Ensuring that Safeguarding Compliance Monitoring Programme is kept up to date
- Provide assurance on local safeguarding activities to the Clinical Services Matron/Vasectomy Safeguarding Lead, UK Named Nurse and the Safeguarding Group Meeting.

Other

- Deputise for the Vasectomy Clinical Services Matron during periods of absence
- Maintain own registration and professional standards, in line with Nursing and Midwifery Council guidelines
- Ad hoc project work as directed or required
- Any other reasonable duties as requested by the Centre Manager
