- Clients are cared for in a safe, clean environment
- They promote excellence in client experience ensuring clients are treated with dignity and respect
- They provide strong clinical leadership and management of the MSIUK Vasectomy service.

The CSM will make a proactive contribution to planning for and improving future services within the Vasectomy service and take an active lead in service transformation. This role will operate within the clinical quality governance framework of MSIUK and will work collaboratively with the multidisciplinary team in the Vasectomy service in the interests of developing and promoting high quality patient care

The post holder will work with the UK Head of Vasectomy and Commissioning Services and Director of Quality and Governance to:

- Lead the quality and standards of care agenda, particularly providing assurance around compliance with regulatory and internal standards of care
- Ensure effective processes are in place within the Vasectomy service in order to ensure high quality patient care, experience and outcomes
- Be responsible for clinically leading the Vasectomy team, co-ordinating the delivery of patient

care within the clinical environment

- Through clinical leadership, knowledge of MSIUK's core values and utilisation of effective
 management skills will ensure that the Vasectomy team is informed, trained and developed to
 enable high quality care to be delivered to patients. This will be achieved through appropriate
 deployment and supervision of clinical staff, as well as practice and professional development
- Support clinical and safeguarding supervision for the Vasectomy team, including offering optional supervision to sessional team members
- Ensure a positive culture of clinical excellence, openness, professionalism, continuous improvement and high-quality care is embedded and promoted within all clinical staffing groups
- Be the service lead expert on all issues relating to clinical practice, providing guidance on clinical and policy issues
- Engage with service lead experts to facilitate active and relevant support within the Vasectomy service
- Appropriately and sensitively respond to Vasectomy-related incidents and complaints
- Act as a visible role model providing positive, professional and accountable leadership to clinical staff
- Fulfil the role of line manager for direct reports, and support with line management of associated team members
- Raise the profile of the Vasectomy and LARC services at MSIUK
- Encourage engagement and development of a specialist team, actively recruiting according to values, in order to meet clinical requirements

Key Responsibilities

- Lead and champion the clinical priorities and establish performance monitoring and reporting arrangements to demonstrate progress within the Vasectomy service
- Lead and provide professional clinical leadership within the service
- Ensure that the professional contribution of all staff within the Vasectomy service are firmly aligned to the achievement of the Region wide objectives
- Ensure the implementation of the Vasectomy service governance and risk management strategies
- Ensure the Vasectomy service maintains compliance via effective outcomes and governance in respect of external regulation such as the Care Quality Commission



- Lead workforce planning/profiling initiatives to ensure there is an optimal staff workforce which reflects good safe, timely, quality care and value for money within the Vasectomy department
- Establish and maintain effective communication links with the UK Head of Vasectomy and Commissioning Services and all staff involved with the Vasectomy service
- Establish and maintain effective communication links with the key working relationships to the role, ensuring the Vasectomy and LARC services are well supported and advised

Clinical and Professional Leadership

- Provide reports and recommendations to the UK Head of Vasectomy Services and the Director of Quality and Governance on patient quality
- Have overall responsibility and accountability for standards of clinical care and the quality of the Vasectomy service
- Ensure clinical skills are maintained and that the clinical skills of all clinical and non-clinical staff
 in the Vasectomy team are up to date. Participate in the delivery of clinical care when required to
 maintain own competence and credibility
- Implement robust systems to evidence and monitor the clinical contribution to national and local standards of care to lead on the following in the Vasectomy service:
- Performance review process
- Clinical quality audits
- Systematically lead on the monitoring of standards of nursing, utilising nursing assurance and performance frameworks and using nursing sensitive key performance indicators which demonstrate continuous improvement and assurance in clinical care and standards for the Vasectomy service
- Act as role model, mentor and coach ensuring that direct reports and indirect reports in the Vasectomy service are supported to achieve their potential with clear goals and priorities
- Attend, lead and participate in meetings and professional forums as required by the Head of Vasectomy Services, providing timely and appropriate communication and dissemination of information
- Act as a visible ambassador for the Vasectomy service within MSI UK, presenting at internal and external professional forums, and influencing focus and change in the department
- Monitor and share both the success and the areas for improvement within the Vasectomy service
- Ensure all clinical staff in the Vasectomy team act at all in times in line with the MSIUK values and the Nursing and Midwifery Council Code of Conduct.

Ensure effective communication and staff involvement throughout the Vasectomy service, ensuring that staff views on change and service development are regularly sought and acted upon

 Lead on active engagement with Vasectomy team members on a regular basis, to facilitate an open and harmonious team (including monthly HWAID reviews; monthly team meetings; quarterly



clinical supervision; quarterly Safeguarding supervision; bimonthly newsletters; ad-hoc 1-1's; and additional individual support where required)

- Maintain active status on professional register (e.g., NMC), and engage fully with revalidation
- Ensure that all adverse clinical incidents are promptly reported on Datix and investigated as appropriate
- Take the lead role in the investigations of Vasectomy clinical incidents, ensuring that learning from practice takes place
- Ensure that, following urgent or emergency clinical transfers, close communication is maintained between NHS settings and MSUK clinical and medical leadership
- Monitor, review and share patient and colleague feedback to the team and individuals, utilising feedback to reinforce positive practice and highlight room for improvement
- Provide holistic support for the Vasectomy team and other MDT members working alongside Vasectomy

Education, Training and Development

- Utilise outputs from audit, feedback, risk management, incident reporting and complaints to determine changes to both education/training and clinical practice throughout the Vasectomy service
- Lead the development of clinical education for the Vasectomy service
- Contribute to the development of in-house education and training programmes
- Develop a culture which encourages all staff working within the Vasectomy service to be innovative, creative and challenging in the interest of client care and professional practice
- Ensure own compliance and compliance of all staff in the Vasectomy team with regards to mandatory training requirements, maintaining records of training and development undertaken
- Monitor mandatory training compliance rate for the Vasectomy service, tracking training compliance locally, and escalating for support when required
- Ensure that all staff have clear goals and objectives and regular feedback on performance
- Develop and provide adapted and flexible training support, incorporating the needs of individual team members
- Engage with the Clinical Education Lead, as well as other relevant team members, in order to develop effective and relevant training and development for the Vasectomy team

 - Ensure that high quality of care for all is at the heart of everything done, and that the Vasectomy department is compliant with statutory responsibilities, including: CQC requirements, NICE guidelines and Health and Safety
 - o Policies and local policies operate satisfactorily within the Vasectomy service

 - Ensure compliance with policies, procedures and clinical guidelines for self and others within the Vasectomy Satellite Centres and participate in the development of same
- Implement systems and procedures within the Vasectomy service to fulfil the requirements of the MSI Risk Management Strategy including local management and resolution of complaints and concerns, management of Serious Incidents / Near Misses and maintenance of Risk Registers.
 Ensure progress against agreed action plans is made and communicated to all necessary staff
 - Take the lead in investigating clinical incidents in Vasectomy, investigating all incidents and taking action where required



- Collate, present and respond to the known clinical complications of Vasectomy, reporting and investigating each incident, and providing a narrative for changing complication rates and action taken
- Ensure operational delivery of the highest standard of infection prevention and control within the Vasectomy service
- Ensure that assurance arrangements are in place within the Vasectomy service to meet MSI requirements
- Attend quarterly LIGM and mini-LIGM's, in order to provide Governance assurance of the Vasectomy service
- Develop and complete auditing of all Vasectomy sites that is reflective of the company-wide audit scheduling, utilising outcomes to inform site and team improvements
- Promote equality and diversity and ensure that there is compliance with statutory requirements within the Vasectomy service
- Take the lead for Safeguarding in Vasectomy, in liaison with the named nurse and named doctor for Safeguarding
- Translate the corporate Patient Experience and survey results for implementation at Centre level
- Ensure lessons learned are translated into effective and sustainable change

Workforce, Planning and Role Modernisation

- Deliver safe staffing levels, within the Vasectomy service. Ensure long term succession planning and workforce planning is conducted to deliver sustainable clinical staffing within the Vasectomy Satellite Centres
- Ensure all staff within the Vasectomy service receive an annual performance review
- Effective delivery of Vasectomy department human resource functions including staff recruitment, retention, leave management, absence management, conduct, performance, grievance management, investigations and hearings
- Lead on recruitment for the Vasectomy clinical team, including advertising, scheduling interviews, interviewing and liaising with HR for recruitment checks



- Complete administrative tasks for onboarded new starters, including welcome packs and letters, shift planning, expenses advice and updating shared document on team members
- Effective management of Vasectomy service human and material resources.

- Maintain staff IPC information and local monitoring, for example: Covid vaccination status; Flu vaccination status; Lateral Flow testing; risk assessments
- Maintain the contemporary Vasectomy Surgical Site Infection Tracker, with details of risk factors, treatment and investigation
- Disseminate regular IPC updates and information with Vasectomy team members
