The Right Care Advisor will work collaboratively will all team Right Care members to support those patients with more complex medical or safeguarding needs to obtain treatment.

The role is to process all clinical referrals obtained from Health Advisors and other areas of MSI UK following consultations where patients have a medical condition or safeguarding concern that could affect their suitability for treatment at MSI UK.

### **Right Care Advisor**

You will liaise with Doctors, General Practitioners, the organisational named Safeguarding Nurse and Medical Professionals, to obtain patients medical histories to assess their ability to have treatment within MSI UK.

Through robust administration processes the Right Care Advisors' send onward referrals to acute hospitals where required.

#### **Key Responsibilities**

- Comply with Pre-Existing Conditions guidelines to ensure relevant medical history is obtained from patients, General Practitioner or Hospitals, also ensuring consent is confirmed with the patient.
- Process all clinical referrals obtained from Health Advisor team following consultations where patients have a medical condition that could affect their suitability for treatment at MSI UK. This will include both Termination of Pregnancy and Vasectomy procedures.
- Liaise with MSI Doctors, Anaesthetists and Clinical Practitioners for medical information required to support patient's suitability to have medical or surgical treatment at a MSI UK.
- Contact patients General Practitioner and / or other medical professional to obtain relevant medical information as requested by MSI UK Doctors or Anaesthetists.
- If a patient has absolute contraindication to treatment at MSI UK, inform patient of alternative pathway. Arrange appointment with an NHS provider or refer patient to their General Practitioner in accordance with CCG agreement.
- Maintain comprehensive records and update the patient record with relevant notes and agreed action with patients.
- Keep daily progress reports and record on InfoPath/database, escalating service level concerns and delays to the Team Manager.
- Report monthly results of patient referrals to Manager/Operational Management Team.
- Triaging cases where health or safeguarding complexities have been identified ensuring patients who have complexities or vulnerabilities are dealt with efficiently.
- Support team with telephone consultations or administration if appropriate.
- Any other reasonable duties as requested by your Manager/Operational Management Team.

Please note that you may also be required to carry out reasonable additional ad-hoc duties, at the request of your line manager.
